Advocating for safe and healthy food

Toxic Free NC helped farmers and consumers understand the connections between PFAS and agriculture, publishing a policy brief and leading a panel at the CFSA Sustainable Agriculture conference about risks of "forever chemical" contamination for farms. We fought for an equitable Farm Bill and policies that ensure a healthy food system for all.

Victory for clean water!

Alongside state and national partners, we celebrated a long fought-for victory when EPA announced the first regulations of 6 PFAS "forever" chemicals in drinking water. The battle is far from over, but this was an important win for North Carolina, the state with the third highest rate of PFAS exposure in the country.

We provided pesticide education and outreach at labor camps and community events, like the one above right in Wilson, NC, led by Eduardo Páez, who joined us in June as Farmworker Health and Justice Organizer.

Protecting communities from harmful chemicals

Toxic Free NC joined NC communities in holding polluter Chemours accountable and demanding strong, health-protective standards. We fought to ban toxic pesticides like paraquat, advocated for transparency, and raised the alarm about industry efforts to preempt community power. We celebrated when DCPA, a harmful herbicide, was permanently canceled—a victory for farmworker and maternal health.

Protecting workers in a changing climate

Tragically, another NC farmworker died this year because of inadequate protections from heat. Toxic Free NC advocated for a proposed federal rule, collected worker stories, and held a press conference demanding Department of Labor action.

Safeguarding biodiversity

We continued to sound the alarm on the ecological harms of pesticides. In partnership with Durham Bee City and New Hope Bird Alliance, Toxic Free NC hosted a webinar featuring NC bee veterinarian and scientist Elizabeth Hilborn, who authored a book about the devastating impacts of neonic-coated seed contamination on her farm.

Women of Color Farmers Network

It was a year of learning and connection for the Women of Color Farmers Network, with 19 workshops on topics such as mushroom cultivation, storytelling for advocacy, business planning, marketing and branding, and much more. In November, we welcomed Farmer Afraka Yates of Old 30 Dirty Family Farm onto the team as Network Coordinator!
